Data retention

We will only retain your personal data for as long as necessary to fulfill the purposes we collected it for, including for the purposes of satisfying any legal, accounting requirements or safety requirements and for a maximum of five years

Your legal rights

- Object: to the way we use your personal data, in certain circumstances, for the reason that you object to the legal basis we rely on to use your data.
- Restrict: the way in which we use your personal data in certain circumstances.
- Request the transfer: of your personal data to you or to a third party.
- Withdraw consent at any time: where we are relying on consent to process your personal data.
